(Amended) Opening Remarks -Discussion of a recent meeting of the new Puget Sound to Pacific (PS2P) Collaborative, a consortium of three non-profit organizations planning to finish a 200-mile biking and walking trail connecting Bainbridge Island on Puget Sound to the Pacific Coast at La Push. Tim Rensema and Jerry Keck attended a recent PS2P meeting and reported that the group is planning to extend the Olympic Discovery Trail between the Hood Canal Bridge and Port Angeles, with trails running through Port Ludlow. The proposed trails also include installing bridges across Ludlow Falls. The Trails Committee agreed to monitor the project to determine how Port Ludlow trails will be impacted. Tim, Jerry and Larry will attend future meetings and offer input if needed regarding our local trails. Jerry reported that the project got a boost in June 2023 when the City of Port Angeles was awarded a \$16.13 million RAISE Discretionary Grant from the U.S. Department of Transportation. The funds will be used to close 100 miles of gaps between the two regional trails on either side of the Hood Canal Bridge: the Olympic Discovery trail in Jefferson and Clallam Counties, and the Sound to Olympics trail in Kitsap County.

Approval of Agenda

Agenda of 6 February 2024 was approved.

Approval of Previous Meeting Minutes

Minutes of 2 January 2024 meeting were approved.

Sub-Committee Reports

Finance

- (1)Tim R. reported that operating funds (verified with bank) of PLVC Trails are \$2,562.42. Reserves are \$8,742.67, earning \$.75 interest. Total Trail funds: \$11,305.09.
- (2) Amount remaining for operations (minus Cemetery) is: \$2,477.74.

Transactions In January 2024:

01/02: \$278.88 for gravel.

01/02: \$671.72 for sign supplies, trails supplies, refreshments after maintenance work.

01/18: Transfer in from LMC for \$1,000.

01/22: Transfer in from PLVC for \$1,000.

01/26: \$28.07 for sign supplies.

- (3) Total remaining in the Cemetery account is \$84.68. Tim reported that the Trails Committee was not selected for the Cemetery Grant program. He said there were twice as many grant requests as funds available, but no other reasons were given. The estimated cost to conduct the ground penetrating radar survey was \$6,500. Another \$500 was estimated to conduct a survey to find the missing monument. Tim plans to submit an article to the Voice requesting funds for that survey. Another possible source of funding could be LTAC grants in October.
- (4) Given the low amount of operations funds that were transferred (after the checks that were processed from 2023 that were paid in January 2024) that left less than \$500 from our operations expenses. The Committee voted to transfer the \$477.74 remaining in the Operations account from 2023 to the Reserves account as is our tradition at the end of each year.
- (5) Regarding the Reserve account, Tim suggested transferring \$5,000 into a CD at about 4.5% interest rather than leaving it in the savings account earning no or little interest. Moved and seconded but defeated. After some discussion, the committee decided to keep the reserves local and readily available.

Natural Resources

(1) Mark Makarowski thanked the volunteers who helped with the December Project Birdhouse to clean and maintain the approximately 65 birdhouses on the golf course and the adjacent Old Cart Path Loop trail. The effort was featured in the February issue of The Voice. Mark added that he built several more birdhouses.

Stewards

Jane N. reported 61.25 volunteer hours so far for 2024. (Using independent sector.org, national average volunteer hours are now valued at \$31.80).
